TIP #1

Request access to digital evidence as soon as a case is referred. Coordinate with investigators or labs to get preliminary access to repositories or review portals before formal reports are finalized.

Waiting for final reports can delay charging decisions and trial strategy.

Why it matters:

- Helps assess case strength and legal sufficiency sooner
- Identifies evidentiary gaps or follow-up requests early
- Supports timely discovery planning

- **Enable access to digital evidence:**
Any stakeholder with permissions can instantly review evidence from their browser on any computer.
- **Surface key artifacts and evidentiary gaps sooner:**
Prosecutors can guide follow-up requests and investigative priorities while cases are still active.

TIP #2
